
The Council of the Rural Municipality of Moosomin No.121 in the Province of Saskatchewan enacts as follows:

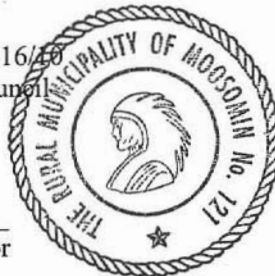
That the following Bylaw be repealed:  
Bylaw No. 177/98 - Zoning Bylaw


This bylaw shall come into force on the date of final approval by the Minister of Municipal Affairs.



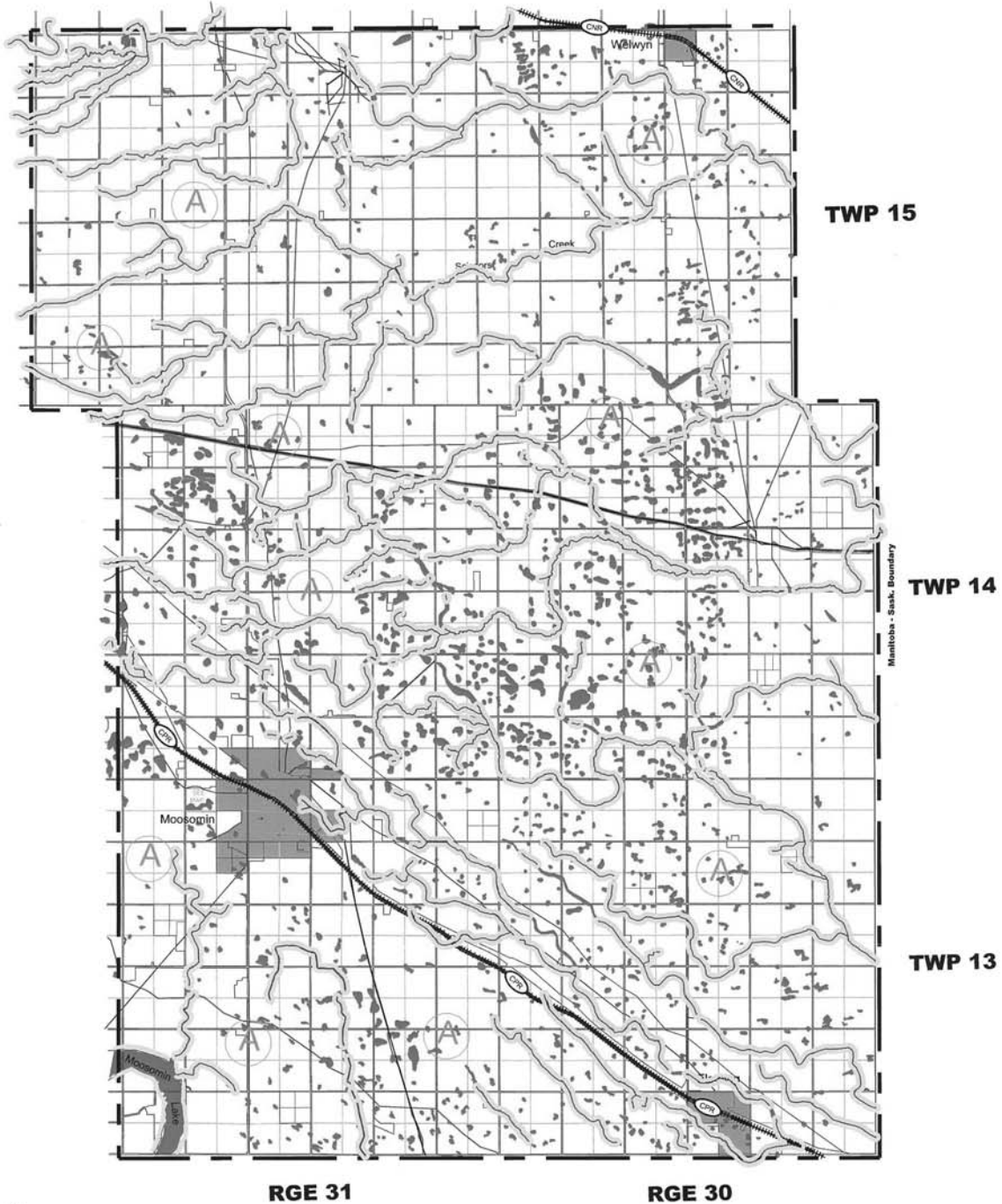

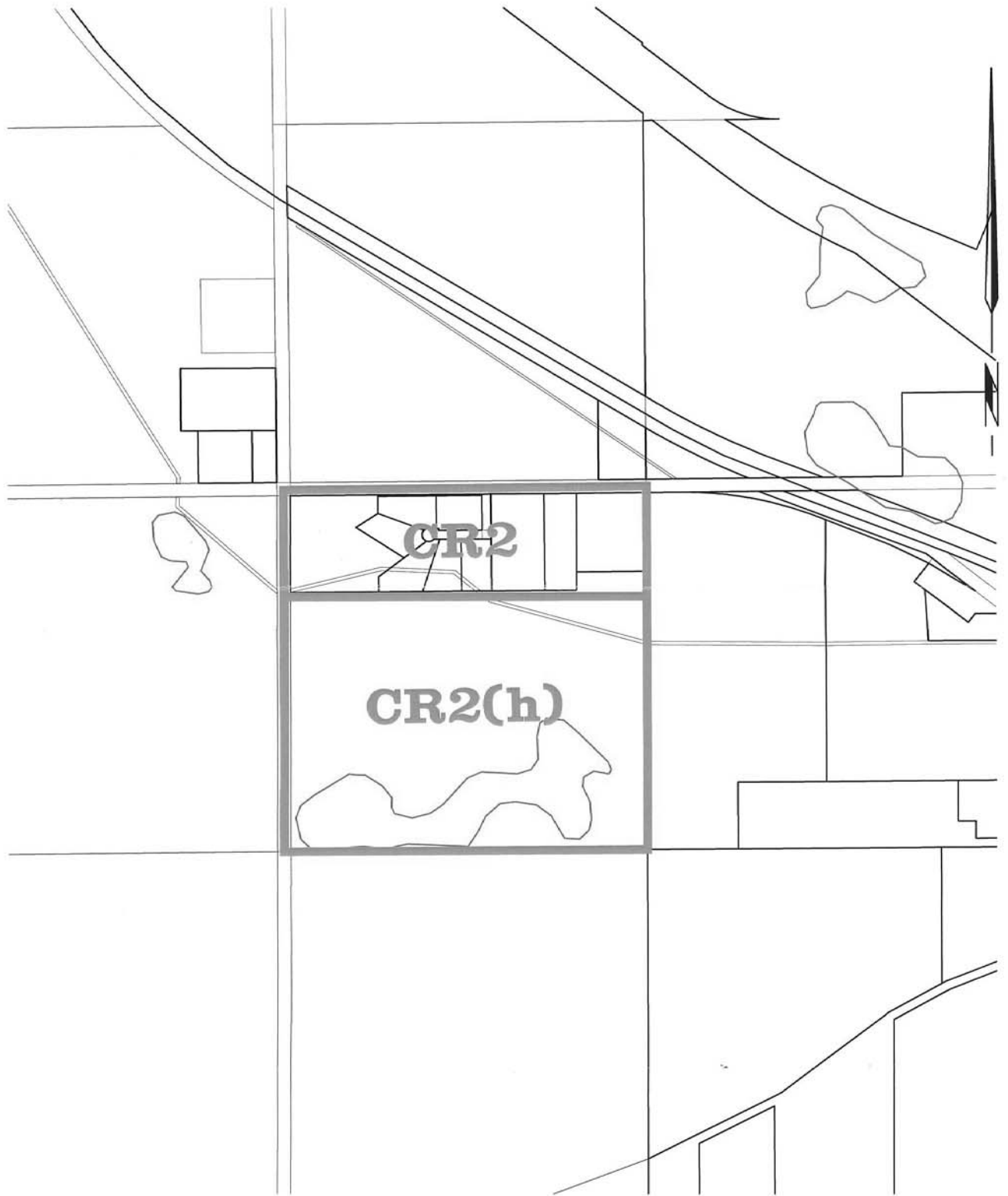
