Bylaw No. 232/13

A Bylaw to amend Bylaw No 215/10 known as the Official Community Plan of the RM of Moosomin No.121.

The Council of the RM of Moosomin No. 121, in the Province of Saskatchewan, enacts to amend Bylaw 215/10 as follows:

1. **The Land Use Concept Map which is attached to and forms part of the Official Community Plan is amended by changing the land use policy from A-Agricultural to CI- Commercial and Industrial on part of the NE and NW ¼ Sec. 27 Twp. 13 Rge. 31 W1M as outlined in bold dashed lines on the map below.**
2. **This bylaw shall come into force and take effect when it has been approved by the Minister of Government Relations.**

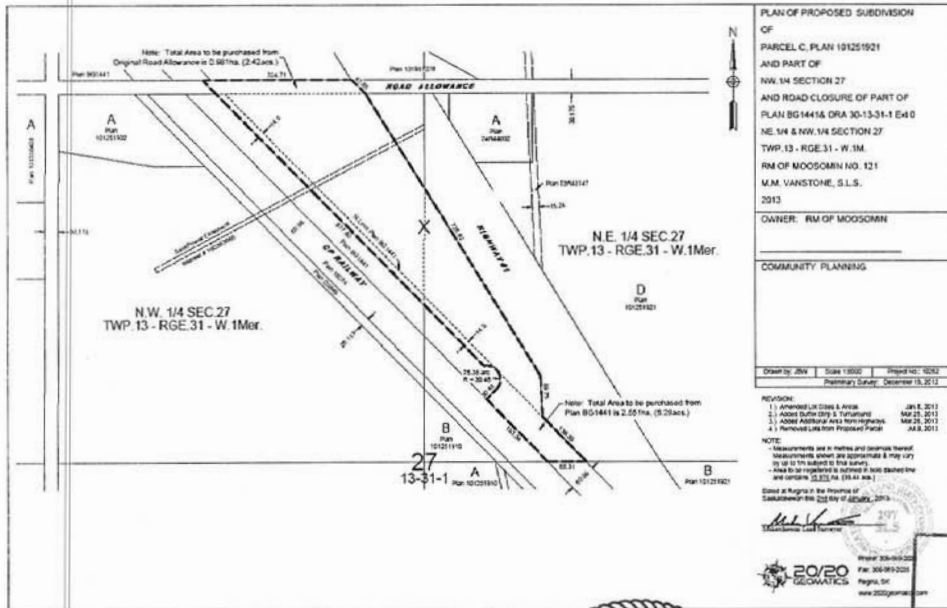

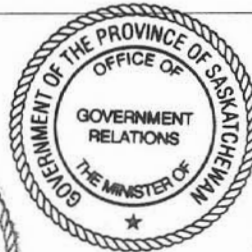
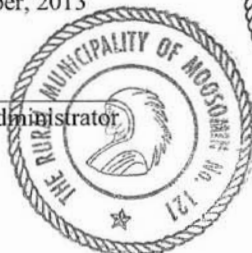
